## Publications Director's Note

In This Edition, The US Postal Service is in OSHA's crosshairs, NJ bakery fails to abate amputation hazards, number of mandated worker death investigations are declining.

#### **BREAKING:**

Department of Labor petitions federal court to force US Postal Service to comply with subpoenas in employee whistleblower investigation;

The department filed a petition today in the U.S. District Court for the Western District of Pennsylvania to enforce its subpoenas issued by its Occupational Safety and Health Administration as part of a whistleblower investigation of the U.S. Postal Service in New Salem, Pennsylvania. OSHA opened the probe in October 2023 after an employee alleged in a whistleblower complaint that she was suspended after reporting safety hazards involving an assigned vehicle and a work-related injury. ## Department of Labor fines New Jersey bakery \$385K after inspectors find workers still exposed to safety hazards at Paterson facility;

PATERSON, NJ – A commercial baker in Paterson faces \$385,221 in federal penalties after a U.S. Department of Labor investigation found the employer failed to correct workplace safety hazards identified in 2023.

The department's Occupational Safety and Health Administration began a follow-up inspection at Valenti's Bakery LLC in May 2024 after the employer failed to prove they had addressed hazards cited by OSHA in a June 2023 inspection. The agency initiated an inspection in 2023 after an employee suffered two partial finger amputations after coming into contact with an automatic blade. #### Department of Labor encouraged by decline in worker death investigations:

Initiatives lead to significant reductions in fatal trench collapses, falls WASHINGTON – Fewer workers are dying from hazards where the U.S. Department of Labor's Occupational Safety and Health Administration has focused its enforcement resources. Preliminary agency data show a decrease in fatalities the agency is mandated to investigate, including significant reductions in fatal injuries from trench collapses and falls, two of the leading causes of death among construction industry workers.

In fiscal year 2024, federal OSHA investigated 826 worker deaths, an 11 percent reduction from 928 in the previous year. Excluding Covid-related deaths, this is the lowest number of worker fatalities OSHA has been mandated to investigate since FY 2017. Up to \$7,500 is available for award among the selected candidates.

- Scholarships are available for high school, undergraduate, and graduate students who
  will be enrolled in the Fall of 2025 in courses leading to a degree in industrial hygiene
  or allied fields such as occupational/environmental health and safety.
- Recipients must be enrolled or planning to enroll in an accredited college in NJ, or be
  a resident of NJ if enrolled or planning to enroll in an accredited college outside of NJ.
- Previous recipients are eligible to apply.
- Minimum cumulative GPA is 3.0.

#### Legislative Updates from NJAIHA: November, 2024

1. Biden-Harris Administration Issues Final Rule Requiring Replacement of Lead Pipes Within 10 Years, Announces \$44M in Funding to New Jersey to Provide Clean Water to Schools and Homes

**NEW YORK** - On October 8th, the Biden-Harris Administration issued a final rule requiring drinking water systems across the country to identify and replace lead pipes within 10 years. The Lead and Copper Rule Improvements (LCRI) also require more rigorous testing of drinking water and a lower threshold requiring communities to take action to protect people from lead exposure in water. In addition, the final rule improves communication within communities so that families are better informed about the risk of lead in drinking water, the location of lead pipes, and plans for replacing them (see EPA's new **Lead and Copper Rule Improvements**).

#### 3. GAO: OSHA Can Do More to Prevent Overexertion in Warehousing and Delivery Sectors

A new report from the Government Accountability Office (GAO) offers five recommendations for OSHA to prevent overexertion among workers in the general warehouse and "last mile" delivery sectors. The report notes that injuries have risen among these workers along with the increase in e-commerce retail sales, citing data from 2021 and 2022 that shows overexertion as the most common hazard in the transportation and warehousing sector, which includes general warehousing and last mile delivery. According to the Bureau of Labor Statistics, transportation and warehousing had the highest serious illness and injury rate among all sectors in 2022, with an estimated 3.8 cases per 100,000 workers.

The recommendations in the GAO report are to add a column for musculoskeletal injuries to OSHA recordkeeping forms, increase training for compliance officers on how to identify and assess ergonomics hazards, clarify existing ergonomics guidance for compliance officers and employers, follow up in a timely manner with employers notified of ergonomics hazards at their facilities, and evaluate the performance of OSHA's national emphasis program for warehouses and distribution centers.
